

Moderator: MR EIRIK SIVERTSEN, Member of Parliament, Norway

Mr Eirik Sivertsen is a Norwegian Member of Parliament representing the Labour Party and the County of Nordland. Mr Sivertsen was elected to parliament the first time in 2009 and was re-elected in 2013 and 2017. In 2013 Eirik Sivertsen was elected as Chair of the Norwegian parliament's delegation to the Arctic Parliamentary Cooperation. From 2014 - 2021 he also chaired the Standing Committee of Parliamentarians of the Arctic Region. In the Norwegian parliament he serves as a member of the Committee on Local Government and Public Administration."



MS TONE WILHELMSEN TRØEN, President of the Storting

Ms Tone Wilhelmsen Trøen is a Norwegian Member of Parliament representing the Conservative Party and the County of Akershus, serving as the president of the Storting since 2018. Trøen was elected to parliament in 2013 and re-elected in 2017. She has been a Member of the Standing Committee on Health and Care Services and chair of the Standing Committee on Family and Cultural Affairs.



MS AILI KESKITALO, President of the Sami Parliament in Norway

Ms. Keskitalo is the current president of the Sámi Parliament in Norway for the term 2017-2021. She lives in Guovdageaidnu. Keskitalo has represented Norwegian Sámi Association (NSR) at the Sámi Parliament since 2005. She was elected the first female president in 2005. Ms. Keskitalo has a master's degree in Public Administration from Copenhagen Business School.



MR IGOR ANANSKIKH,

Deputy Chairman of the State Duma of the Federal Assembly of the Russian Federation

Mr Ananskikh represents A Just Russia Party and the Republic of Karelia, Murmansk oblast and Leningrad oblast. In addition to being a member of the Duma's presidium, he is also a member of the Committee on Energy, and of the Commission on the support of small and medium-sized businesses.



MS HELENE HELLMARK KNUTSSON,

Governor of Västebotten County, Chair of the Barents Regional Council, Sweden

Ms. Knutsson is serving as the Head of County Administrative Board of Västerbotten, a position she has held since August 2020. Prior to this, she was a member of the Swedish Parliament, working as the deputy chair of the Committee of Industry and Trade between 2019-2020. From 2014 to 2020, she held the position of minister for Higher Education and Research in the Swedish government. She studied history, economics, and statistics at the University of Stockholm.



MS INE ERIKSEN SØREIDE.

Minister of Foreign Affairs, Chair of the Barents Euro-Arctic Council, Norway

Ms. Eriksen Søreide is currently serving as Minister of Foreign Affairs of Norway. She served as Minister of Defence from 2013 to 2017. Prior to this, she served as member of the Storting (Norwegian parliament) for 12 years. From 2009 to 2013, she chaired the Standing Committee on Foreign Affairs and Defence. Ms. Eriksen Søreide has a graduate degree in Law from the University of Tromsø.
